I also indemnify the lessor and its employees against and shall hold both harmless from any and all claims, actions, suits, procedures, cost expenses, damages and liabilities—including attorney’s fees arising out of, connected with or resulting from playing paintball/airsoft and/or the equipment including without limitation, the manufacturer, selection, delivery, possession, use, operation of the equipment and the environment. I nevertheless wish to assume any and all risks. I hereby waive and release the lessor on behalf of my estate and all others who may play paintball/airsoft with me. I also undertake to perform all safety suggestions presented to me. I understand full well the intense physical/mental exertion can cause me or others harm. I state that I am in good health. I have read and fully understand the terms of this lease agreement.
